This waiver and release bars your rights to recover damages in the case of an accident injuring you. **READ BEFORE** SIGNING! I promise to inspect the contest site, and assure myself that the area is safe for skimboarding, and further agree that I will not skim or help with the contest, unless I am satisfied that the area and conditions are safe for skimming purposes. In exchange for Victoria Skimboards Inc. accepting my entry form and entry fee, I voluntarily agree to assume all risks involved and hazards connected to the sport of skimboarding. I fully understand and acknowledge the dangers of skimming created by the sharp edges and heavy boards along with natural buoyancy of a skimboard when they are acted upon by the powerful forces of the ocean waves and Mother Nature. With this full knowledge, comprehension of and understanding of these dangers, I voluntarily accept and assume all risks involved in the sport of competitive skimboarding. I will further read and comply with all Victoria Skimboards Pro/Am contest rules and regulations, noting existing weather conditions, and do agree that I voluntarily assume all risks arising from conditions related to use of the contest site by myself and others. In consideration of the acceptance of my entry, I intend to be legally bound, hereby, for myself, my heirs, executors and administrators, to hold harmless and release and forever discharge Victoria Skimboards, Inc., its officers, directors and employees, the County of Orange, the City of Laguna Beach, the State of California, and other sponsors and co-sponsors, their officers, directors, employees and agents, and all other personnel associated with or connected with this competition, from all claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or any of the property belonging to me, whether caused by the negligence of the releasees, or otherwise, while participating in such activity, or while in, on, or upon the premises where the activity is being conducted.

The undersigned further grants to the Sponsors, the right, privilege and exclusive rights and license to the undersigned's name, nicknames, usernames, initials, likeness, image, photographs, voice, autograph, signature, biographical information, endorsement and/or other recognizable aspect of my persona in connection with my participation and presence in this competition.
